 - Budget updates
 - Second budget meeting was held today
 - Boces has had a 5% increase
 - As of right now, Foundation Aid has been restored plus a 3% increase
 - We may not know the official result of the aid prior to approving our budget
 - Tax Cap reported
 - 1.81% increase, will have little impact to tax payers
 - Supply Chain Grant
 - Federal child nutrition grant for hard to get things from the US such as fresh fruit
 - We received \$6,357.00 in grant money
 - Bus #52 Plans
 - Mrs. Moore received a phone call from someone interested in buying the bus
 - We were previously keeping it as a parts bus however we were told it is no longer usable to repair other buses
 - Mrs. Moore asked the Board if we would like to accept bids for the bus, the Board agreed
 - Utica National School Safety Excellence Conference
