#### I. INTRODUCTION

- A. Call to Order The Regular School Board Meeting was called to order at 5:03 p.m. followed by the Pledge of Allegiance.
- B. Roll Call Board President Jacqueline Nichols called for roll.
- C. Welcome Board President Jacqueline Nichols welcomed everyone.
- D. Privilege of the Floor Mrs. Candy Frasier requested to speak to the Board behind closed doors.
- E. Agenda Changes There were no agenda changes
- F. Board Reports/Announcements Board President Jacqueline Nichols commented about the Roast Beef Dinner. Ms. Nichols heard a lot of good comments and wanted to thank all the volunteers and PTO for a job well done.
- G. Superintendent Reports/Announcements Superintendent Hromada briefed everyone on several items. Superintendent Hromada advised the Board that the Dental Hygienist was here and saw 21 students and is scheduled for a return visit on November 21, 2016.

Ms. Hromada is working with B/P and NCS to make sure we are on the same calendar days for PD days. Also, we will make sure that Parent Teacher Conference Days are on the same schedule as NCS. Ms. Hromada presented a Substitute Tidbits that goes over procedures for cafeteria and playground etc. Ms. Hromada talked about the October PD day that was well received and was based on the importance of word work, vocabulary, and grammar presented

by Mrs. Paster and Mrs. Ellis. Presentation was based on <u>Bringing</u> Words to <u>Life</u> by *Isabel Beck*.

The January PD Day will be based on Social Media. Our Attorney's from Girvin and Ferlazzo will be here as well as 2 presenters on Reading and Project Based Learning.

Ms. Hromada advised the board that two more readers have been added to the list of volunteers. Applications have been completed and screening will be done.

A survey was done by the staff on what is going well and any concerns. Staff will brainstorm on solutions. Process can be overwhelming to get to the point where we need to be.

Ms. Hromada spoke about the tuition and will have a further discussion later on in the meeting.

Mrs. Moore gave an update on the HVAC system. All rooms are functioning at 47%. Air filter's or air ventilation units need to be cleaned. Fan coils are the original. Received a quote to clean air ventilation units in amount of \$6,000. Once units are cleaned then our maintenance department can change the filters. Also the exhaust unit in gym is very loud. This fan is now part of the airflow which will turn on and off frequently. M & E Mechanical recommended to install a centrifical fan at a cost of \$10,000. On November 17 Trane will come and teach staff how to control the fan.

Mr. Sitts and Ms. Hromada provided a presentation on all test data and reading, analyzing the data and what to do with the data they don't like. There are three core principals

- 1. What do we want our children to learn (Standards)
- 2. How do we know they learned it (Data Driven Instruction)
- 3. What do we do if they have not learned it (RtI)

Ms. Hromada discussed the tuition policy for Out of District Students. Out of eight schools in our region 4 are open enrollment and 4 charge tuition. We currently have 8 students out of district that pay tuition and 2 staff children that do not pay tuition. Board will discuss and get back to Ms. Hromada on decision for either open enrollment or to charge tuition.
